## **GM / Development Report:**

Gary: one staff member is awaiting the results of his covid test. Most staff members are working remotely and coming to work as needed. Staff members continue to be scrupulous with getting tested.

- Federal funding is stable for now. We are forward funded so some funds not available until 2024.
- New transmitter has been purchased and will be installed soon. The new device will be stronger, faster and cheaper to use. It will be usable for future upgrades.
- KSPS has purchased a new all-terrain vehicle that will allow the engineering team better access to remote transmitter sites. A trailer will be purchased as well. We will no longer need to rent a vehicle to facilitate repairs.
